

AN ORDINANCE

AMENDING ORDINANCE 01-439 OF SUMTER COUNTY, SOUTH CAROLINA (THE 2001-2002 SUMTER COUNTY BUDGET ORDINANCE) BY INCREASING THE AMOUNT OF ANTICIPATED FUNDS, MONEYS AND REVENUES ESTIMATED TO BE RECEIVED BY SUMTER COUNTY FROM ALL RESOURCES OTHER THAN AD VALOREM TAXES, INCREASING THE AMOUNT TO BE ALLOCATED TOWARD THE 2001-2002 BUDGET OF Sumter County OUT.

BE IT ORDAINED by the Sumter County Council for Sumter County, South Carolina, in Council duly assembled:

1. That Sumter County Ordinance 01-439 (the 2001-02 Sumter County Budget Ordinance), is hereby amended as follows:

A. That the first "WHEREAS" clause on page 1, the figure "\$400,000" is stricken and there is inserted in lieu thereof the figure "\$587,745"

B. That, in the table in Section II, the following figures are added to the appropriate departments as a follows:

D. That in the table in Section II there is inserted from the line corresponding to SUB-TOTAL COUNTY EXPENDITURES the figures of "\$35,864,740,"

E. That in the table in Section II, there is stricken from the line corresponding to TOTAL APPROPRIATIONS FOR EXPENDITURES to be made by Sumter County in 2001-02 Fiscal Year the figure of "\$37,322,010" and inserted in lieu thereof the figure "\$37,509,755,"

F. That, in Section X, the figure "\$400,000" is stricken and there is inserted in lieu thereof the figure "587,745,"

G. That there is stricken from the line corresponding to Account 001-000-4-999-97 Authorized Reserved Usage on Exhibit "A" the figure "\$400,000" as the amount approved for fiscal year 2001-2002 and inserted in lieu thereof the figure "\$587,745,"

H. That there is stricken from the line corresponding to Account 001-000-4-999-97 concerning Authorized Reserved Usage on Exhibit "A" the figure "<\$874,185> as an amount OVER (+)/UNDER (-) and inserted in lieu thereof the figure "\$686,440)"

I. That there is stricken from the line corresponding to TOTAL REVENUES on Exhibit "A" the figure "\$35,536,452" as the amount approved for fiscal year 2001-02 and inserted in lieu thereof the figure "\$35,724,197," and

J. That there is stricken from the line corresponding to REVENUES on Exhibit "A" the figure "\$268,860" as an amount OVER (+)/UNDER (-) and inserted in lieu thereof the figure "\$456,605," and

2. That this Ordinance shall take effect upon its adoption.
