

**AN ORDINANCE AMENDING ORDINANCE 03-496 OF SUMTER COUNTY, SOUTH CAROLINA (THE 2003-2004 SUMTER COUNTY BUDGET ORDINANCE) BY CHANGING THE AMOUNT OF ANTICIPATED FUNDS, MONEYS AND REVENUES ESTIMATED TO BE RECEIVED BY SUMTER COUNTY FROM ALL RESOURCES AND CHANGING THE AMOUNT TO BE ALLOCATED TOWARD THE 2003-2004 BUDGET OF SUMTER COUNTY.**

WHEREAS the Sumter County 2003-04 Budget Ordinance was also amended by Sumter County Council members through its Budget Ordinance Amendment 03-510, which was approved on September 9, 2003;

NOW THEREFORE BE IT ORDAINED by the Sumter County Council for Sumter County, South Carolina, in Council duly assembled:

1. That Sumter County Ordinance 03-496 (the 2003-04 Sumter County Budget Ordinance), is hereby amended as follows:

A. That the first "WHEREAS" clause on page 1, the figure "15,699,026" is stricken and there is inserted in lieu thereof the figure "\$15,779,026", and the figure "0" is stricken and there is inserted in lieu thereof the figure "\$80,000."

B. That, in the table in Section II, the following figure is added to the appropriate department as a follows:

Department	Purpose	Amount Appropriated
Matching Grants Transfer	FEMA Matching Funds	\$80,000

C. That in the table in Section II there is stricken from the line corresponding to SUB-TOTAL the figure of "\$36,964,216," and inserted in lieu thereof the figure "\$37,044,216."

D. That in Section II there is stricken from the line corresponding to TOTAL APPROPRIATIONS FOR SUMTER COUNTY IN FY 2004 the figure "\$38,780,350" and inserted in lieu thereof the figure " \$38,860,350."

E. That, in Section X, the figure "\$0" is stricken and there is inserted in lieu thereof the figure "\$80,000."

F. That there is stricken from the line corresponding to Account 001-000-4-999-97 Authorized Reserved Usage on Exhibit "A" the figure "\$0" as the amount approved for fiscal year 2003-2004 and inserted in lieu thereof the figure "\$80,000."

G. That there is stricken from the line corresponding to Account 001-000-4-999-97 concerning Authorized Reserved Usage on Exhibit "A" the figure "(\$276,075) as an amount OVER (+)/UNDER (-) and inserted in lieu thereof the figure "(\$196,075)."

H. That there is stricken from the line corresponding to TOTAL REVENUES on Exhibit "A" the figure "\$36,964,216" as the amount approved for fiscal year 2003-2004 and inserted in lieu thereof the figure "\$37,044,216," and

I. That there is stricken from the line corresponding to REVENUES on Exhibit "A" the figure "\$198,390" as an amount OVER (+)/UNDER (-) and inserted in lieu thereof the figure "\$278,390," and

2. That this Ordinance shall take effect upon its adoption.
